My primary current research interest is the response of British leaders and the public to the arrival of U.S. personnel in Britain and France during the First World War. Although many scholars have explored the arrival of U.S. personnel during World War II, the earlier conflict was the first occasion for large numbers of U.S. troops and citizens to visit Britain or Europe. Yet no major studies have been published on the British responses to Americans during the First World War.

My other areas of academic interest are British World War I memorials and the use of film in the study of history, especially 20<sup>th</sup> century Britain. Additional areas of expertise include study abroad program development, campus internationalization, strategic planning for internationalization and international faculty development.

My current teaching offerings are in modern British and Irish History, and the History of Nazi Germany and the Holocaust.
